With reference to your letter of 12th inst. regarding the appointment of an additional land ranger in the East African Protectorate, I have the honor to inform you that the Government are prepared to support the proposal in the first instance. With reference to the question raised in the last paragraph of your despatch under acknowledgment, the British Mine supplies all silver and copper coins to the Government free of charge delivered at Durban. I am still of opinion that in the question of the appointment of the Indian Government in this light a similar arrangement might be obtained from the British India Mine in respect of those Sterling delivered at Durban. As you are aware, the Governor is away on tour and I have not been for some time. I have written to the Secretary of State in order to allow of your making representations in regard to the appointment of an additional land ranger in the East African Protectorate. Sir,

I have the honour to inform you that the question of appointing an additional Land Ranger has arisen and I feel that the matter is of sufficient importance for me to ask that the appointment may be made during the present year.

2. Owing to the rapid development of the Protectorate as a whole the work of the Land Office has increased enormously, and consequently it has been found necessary to employ one of the Land Rangers almost continually in the office to deal with routine work, leaving the other free to travel and make the many farm inspections which the regulations necessitate.

3. The Chief Land Ranger, Mr. Tannahill, prior to his going on leave was taken away from his usual duties in order to undertake the assessment in Nairobi and as a temporary measure an officer from the Survey Department was seconded to act as Land Ranger, but his services will not be available after August 1st as he is proceeding on leave, and there will be no one then to inspect the farms as Mr. Dundas must be at headquarters.

4. The Assistant Land Officer, the Chief Land Ranger and the Office Superintendent are now all on leave and the work in the Land Office cannot be carried on satisfactorily with its present staff.

5. The Land Officer had intended asking for the appointment of an additional Land Ranger at the time when the estimates for the current year were being prepared but owing to his absence on leave the matter was overlooked. Even with the full staff present, I consider that this appointment ought not to be delayed, and I hope that you will consider the matter of sufficient urgency as to sanction his appointment at once.

6. There will be no specific savings on any of the Land Office Votes from which his salary could be met this year and it will therefore be necessary to find the money from general savings and provision will, if you approve, be made in next year's estimates for the post at a salary of £300 by £20 to £400 with £50 house allowance.

7. I had hopes of being able to find a candidate here who would have been very useful owing to his knowledge of local conditions but as the only suitable person has found other employment I must ask that the new officer be appointed from home. His essential duties would be to inspect farms which have been leased by the Crown and to report to the Land Office whether the tenants are fulfilling the covenants of their leases. This involves valuation of buildings,

wells.

wells, irrigation furrows and fencing, and a knowledge of the cost of breaking up ground preparatory to planting, the measurement of acreage and the value of crops grown by lessees is also necessary. He should, if possible, be a professional Associate of the Surveyors Institute or at least have a good knowledge of survey work. A public school boy would be preferred and as a great deal of his work will be out of doors he should be strong physically.

8. Sir Percy Girouard is fully acquainted with the facts of the case and after consultation with him I trust that you will give this matter favourable consideration.
