THE VACCINATION ORDINANCE, 1912.

LEGAL REPORT.


1. This Ordinance has been enacted to enable the Governor to order that vaccination against small-pox shall be compulsory in any Township, District or Area in which it is considered that the provisions of the Ordinance can and should be enforced.

2. The Ordinance is modelled on the Bengal Vaccination Act 1880, the Zanzibar Vaccination Decree 1910, and the Northern Nigerian Ordinance No. 12 of 1908.

3. Power is given to the Governor to exempt any person from the operation of the Ordinance when satisfied that vaccination is prohibited by or is repulsive to his creed or religion.

4. In my opinion this Ordinance is a proper Ordinance to be enacted for this Protectorate and may be assented to without previous submission to the Secretary of State.

THE VACCINATION ORDINANCE, 1910.

Section 3 (1) The Governor may order making Vaccination compulsory.	(1) Under this Section provision is made making vaccination compulsory as regards all unprotected persons in any specified area.
Section 3 (2).	(2) Section 19 of the Zanzibar Decree. The word "customs" has been omitted from the East Africa Ordinance. It is considered that only objections based on religious grounds should be recognised as a reason for exemption.
Section 4. Public Vaccinators.	Under this Section the Principal Medical Officer can appoint either a Medical Officer in the service of the Government or a private practitioner to be the Public Vaccinator in and for any area. As the Public Vaccinator is prohibited from charging for anything done under the Ordinance, provision must be made for remunerating any private practitioner who may be appointed to be a public vaccinator.

Under this Section all unprotected adults are required to submit themselves for vaccination within one month of the application of the Ordinance to any area on which they reside. This Section has been altered so as to cover persons coming into the area after the application of the Ordinance.

Section 21 of the Northern Nigerian Proclamation No. 13 of 1908:

This Section requires all unprotected children within any area to which the Ordinance is applied to be submitted for vaccination before they attain the age of 6 months. Unprotected children who are over the age of 6 months when the Ordinance is applied or who being over the age of 6 months are brought into the area after the Ordinance has been applied must be submitted for vaccination within one month of the application of the Ordinance or of their being brought into the area. The age has been altered from 3 months to 6 months on the recommendation of the Principal Medical Officer.

This is a necessary provision and gives effect to the practice in Zanzibar where vaccination is mainly carried out on a house to house visitation.

Under the powers reserved restrictions should be made safeguarding the rights of the subjects of the Treaty Powers in the Sultan's Dominions, and regulating the invasion of the women's quarters in a Mahomedan's household.
