Sir:-

I am directed by Secretary Sir E. Grey to inform you, for the information of Mr. Secretary Harcourt, that a certain Alfred Hawkyarde Hinde was convicted of unlawfully and maliciously wounding at Tangier and sentenced by the Chief Justice of Gibraltar on January 17th. to four months imprisonment with hard labour.

His Majesty's Consul General at Tangier has asked the Attorney General to apply for an order of deportation against this man and in order to assist him better in making this application, has requested that the authorities in British East Africa may be called upon to furnish a copy of Hinde's record as Mr. White understands that he has already served a term of imprisonment in that country.

I am therefore to request that Mr. Harcourt may see fit to instruct the British East Africa Authori-

ties.
