I have the honour to attach Statements of expenditure incurred by the Imperial Institute on the equipment of (a) the British East Africa Court and (b) the Sierra Leone Court.

Authority was given under C.O. letter No. 10867/1906 of the 6th April 1906 to incur such expenditure up to £100 on the British East Africa Court in connection with the arrangement of exhibits received from the Liverpool Exhibition.

In the case of Sierra Leone, Sir L. Probyn, who was then Governor of that Colony, informed me in a letter dated 5th April 1907 that £100 was provided on the Estimates, and that expenditure within that sum might be incurred on the equipment of the Sierra Leone Court.

These accounts have been held in suspense in the books of the Imperial Institute and the Colonial Office, and expenditure has from time to time been debited against these special grants in the Imperial Institute accounts rendered quarterly to the Board of Trade and the Colonial Office, respectively.
