Dear Sir,

We beg to acknowledge receipt of your letter of 23rd December giving the terms of our arrangement under which the new Company is to be formed to take over your lease of about 500 square miles of British East Africa.

We have not examined the lease, but understand that it has eighteen years to run, the sole condition being the payment of £600 a year rent, whilst the owner has the option to purchase the free-hold during the period of the lease for £60,000.

We are in agreement with your recapitulation of the terms of our arrangement, and as you desire to have our association with Messrs. Bovril Limited explained, we would mention that our capital is £250,000 divided into Preference and Ordinary Shares. The whole of the Ordinary Shares, which have the controlling rights, are owned by Messrs. Bovril Limited, and this class of business, when they desire to be interested in it, is attended to by us, all the Directors of our Company being Directors of Bovril Limited.
