I have the honour to refer to your despatch No.130 of the 4th of March 1912 on the subject of the rate of house allowances for European subordinate Officers and to explain that it has remained so long unanswered for the reason that the question of house allowances at out-stations is to a certain extent involved with that of camp and travelling allowances and it was considered advisable by the Officers administering the Government to await a final decision on the latter before reporting on the former.

2. The question of travelling allowances has now reached its final stage and I am in possession of your views on the subject of camp allowances and there is therefore no longer any necessity

necessity for further delay in replying to your despatch respecting house allowances.

3. Enquiry has elicited the fact that it is not possible at any station in the Protectorate, whether at Nairobi, Mombasa or elsewhere, to obtain the use of private buildings suitable for occupancy by Europeans at a lower rental than Rs.50 per mensem or 140 per annum and I accordingly most strongly recommend that the 140 rate be approved for all Clerks and other European subordinates who may be required to rent quarters regardless of where they may be stationed.
