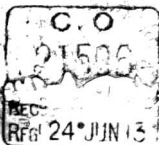

Sir,

I have the honour to raise the question of granting some extra remuneration to the Gun Registration Clerks at Mombasa who are frequently required to work overtime in order to deal adequately with the increasing importation of firearms into this Protectorate.

2. The nature of the work which these Clerks are called upon to perform entails many hours being spent at Kilindini and involves constant travelling between that Port and the Head Office at Mombasa where it is essential that the purely clerical work should be kept up to date.

3. As these Clerks work conjointly with

the Customs Staff, who receive additional pay for overtime, I am of opinion that a somewhat invidious distinction exists and I have accordingly sanctioned the grant of a bonus to the former on the same scale as that drawn by the latter.

4. As the Shipping Agents are generally prepared to pay this allowance and the Chief of Customs has undertaken to collect it from them, the Government will be relieved of any embarrassment in the matter and I therefore venture to hope that you will endorse the action which I have taken.
