CUSTOMS TARIFF AMENDMENT ORDINANCE

Proposed to add Acetic Acid to free list.  
Uganda agrees. Request's sanction.

*Privy. Council*  
*In Reply to the Secretary of State (2 papers)*

We have no bones to pick on export duty, or cultivated rubber for the present, in order to give the industry a chance to establish itself. But I doubt whether we should go so far as to subsidize the industry by removing the import duty on materials used in its production. If acetic acid is used so extensively in the Provenor assets, the loss of revenue due to the remission of the import duty would be considerable. The question of such an exemption of acetic acid has not been raised before, and this request seems to have been stimulated by an concession in it regard to export duty on cultivated rubber.

We exempt soda plants etc and machinery and apparatus used in agricultural work, but also chemical manures, but in Uganda, Nyasaland and S. Afr. *held in substance* used in the preparation of agricultural products. *for the fact that in considering the*

I have the honour to refer to my despatch No. 407 of the 28th of May respecting the proposed Customs Tariff Amendment Ordinance.

2. The Bill, as I have already reported, has not yet passed its third reading, and it has been represented to me that the opportunity might be taken of adding Acetic Acid to the list of articles exempted from import duty.

3. It is estimated that nearly one quarter of the cost of production of Ceara rubber is due to the amount of this acid used. Ceara rubber is in itself a low value commodity, and if it is to continue as an industry in this Protectorate

its production must be made as inexpensive  
as possible.
