Foreign Office, July 3rd, 1913.

No. 11.

Pursuit of Boran Tribes into E. Africa by  
Abyssinians.

My telegram No. 5 of May 31st.

The Colonial Office have sent a despatch in  
the following sense to the Governor of E. Africa.

Boran should be allowed to remain in British  
East Africa and protection from further ill treatment  
should be afforded <sup>them</sup> ~~him~~. No reliance can be placed  
on guarantees for <sup>them</sup> ~~his~~ good treatment.

It is essential to maintain a firm attitude.  
Further raids are likely to result from the proceedings  
reported.
