

RULES

made by His Excellency the Governor under
Section 121 of the Customs Ordinance
1910.

IMPORTATION AND EXPORTATION OF GOODS
BY INLAND CARRIAGE OR NAVIGATION.

1. The Master of every ship or his agent whether the ship be laden or in ballast shall within 24 hours after arrival at any port on Lake Victoria Nyanza within the jurisdiction make due report of such ship in the form Schedule A to these regulations with such duplicates thereof as the Chief of Customs may require
2. No goods shall be discharged from any ship at any place or places within the jurisdiction on Lake Victoria Nyanza except such as have been appointed ports or sub-ports under Section 118 of the Customs Ordinance 1910.
3. No goods shall be discharged from any ship on the Lake Victoria Nyanza within the jurisdiction unless with the permission and in the presence of the proper Officer of Customs.
4. All goods landed at any Lake Port within the jurisdiction shall be duly entered in the forms prescribed by the Customs Ordinance 1910 for goods imported from ports beyond the seas so far as those forms are applicable and subject to any instructions which may be issued by the Chief of Customs under Section 119 of the Customs Ordinance 1910.
5. Within 24 hours after any ship shall have been cleared from any Lake Port within the jurisdiction whether laden or in ballast, the master or his agent shall make due report of such ship in the form Schedule B hereto.
