I think we might wait for Dr Milne's reply before taking any steps, but it will be well to let him know that the Secretary of State's attention has been specially drawn to the typhoid question, and that two cases have occurred since he left the Protectorate.

Dr. Milne and the Medical and Sanitary Committee (including Sir W. Leishman, who is in charge of the inoculations for the Army) are all in favour of inoculation against enteric in the East Africa Protectorate and there seems to be no reason for deferring action.
