EAST AFRICA SYNDICATE LIMITED.

Sir,

With reference to the interview which Colonel Villiers had with Mr. Read on the 18th instant, I am requested by my Directors to inform you that owing to the criticisms to which I referred in my letter of the 9th October, it has been impossible to frame a satisfactory agreement with the Bovril group previous to the expiry of the underwriting within the next few days. It is no longer feasible to carry through the formation of the contemplated Company, The East Africa Cattle Farms Limited, and my Board, after due consideration, wishes to place a fresh scheme for the development of the land grant before the Colonial Office and the Governor of East Africa.

Owing to the influx of settlers into East Africa, my Directors are of the opinion, and have been advised by those intimately acquainted with local conditions, that it would be in the best interests of the country that the land should be surveyed, reported upon, and classified by a suitable agricultural expert, and then divided into conveniently sized blocks for general farming, stock raising and agricultural purposes. As soon as this has been accomplished, the blocks could be advertised and offered for sale by auction and otherwise, and where necessary, easy terms of payment afforded to those purchasing. The East Africa Syndicate would be prepared to assist purchasers wishing to go in for stock raising,

by selling them drafts of cattle and sheep from its stock on favourable terms.

I am directed to point out that though the Syndicate has the right to sell the land, according to its original grant, so soon as it has paid the purchase consideration, viz., £50,000, approximately 3s.2d. per acre, it nevertheless wishes to suggest for H. M. Government's consideration, a better and quicker way of dealing with the proposition, instead of waiting till the land sufficiently appreciates in value to warrant the payment of the £50,000.

My Directors therefore desire to know whether H.M. Government will allow the Syndicate to pay a pro rata proportion of the purchase price (which freeholds the land) as and when each parcel or block of land is sold, provided no block be less than one thousand acres. In this way, the Government would be paid at the rate of 3s.2d. per acre as and when the land is dealt with, and the land be gradually settled, which would benefit the railway, and be of great advantage to the Protectorate.
