(1) One man one free at one sale
(2) No one to bid who held land of the Govt already

As regards conversion of title, we must I think finally give way, as the Govt is strong on the point of uniformity.

It means that the price we get at future auctions will be determined by what existing holders, who have either got their land by allotment (i.e. without premium) or at auction for an occupation licence title, will sell their converted title

Sir,

I have the honour to acknowledge the receipt of your Confidential despatch of January 9th, 1914, on the subject of the rules regarding the alienation of land in this Protectorate, and I note with satisfaction that you have been pleased to approve the removal of the restrictions on purchase mentioned in my Confidential despatch of November 18th, 1913.

2. With reference to the question of the substitution of title under the new Ordinance for existing leases and licences, I desire to express my view that little disadvantage, if any, will arise as the result of such concession, and that if such is in fact apparent it will be more than counterbalanced by the advantages attendant on the retention of a principle which encourages uniformity of title and of the terms of occupation. I would observe that the power of controlling the operations of the holder of an occupation licence will be in no way weakened by the admission of this principle, as the obligations

obligations imposed by the conditions of a lease under the new Ordinance, and the penalties resultant on non-compliance therewith, will enable a strict supervision to be maintained over the proceedings of the lessee as over those of the holder of a licence.

3. As by paragraph 4 of your despatch under reply you have been pleased to leave to my discretion the retention or variation of the principle of automatic conversion, I propose to retain in the draft Bill those clauses which legalise such conversion and prescribe the means of effecting it.


