With reference to your letter No. 721 of the 28th ultimo, I have the honour to inform you that I was absent on our circuit at the time when your telegram of June 24th was received and that the matter was dealt with by the Acting Chief Secretary, who was advised by the Commissioner of Police and the Attorney General that as the Magistrate declined to commit a prisoner on the acceptance of a photograph as evidence of the identity of Diekmann, they considered it desirable that some one should be sent out to identify him. It was so accordingly telegraphed to you to that effect on July 2nd.

3. I may observe that the photograph enclosed in your despatch No. 59 of the 28th June did not arrive here till the 1st of July and as the trial did not take place till the 25th inst. I was unable to say whether the Magistrate was satisfied earlier than I did in my telegram of the 20th ultimo which apparently however was too late to prevent Mr. Douglas from starting.

4. Even so judgment in the case was not actually delivered until the 20th July but the assurance that the Magistrate had accepted the identity of Dickmann by the photograph was telegraphed to headquarters on the 25th instant because the importance of stopping Mr. Douglas was realised if he was not needed.

5. I regret that the Vacuum Oil Company have been put to inconvenience and unnecessary expenditure but I trust you will agree with me that this was quite unavoidable and I hope my explanation will prove satisfactory.

With reference to your G. 8833 dated 25-8-14

I have the honour to inform you that an endeavour was made to ascertain from the Magistrate whether or not he would accept photograph as evidence with the result communicated to you in my P. 470/21/14 dated 27-6-14 (copy attached).

2. The accused was represented by Counsel and I am of opinion that it was necessary in this as in all criminal cases to endeavour to obtain the best evidence as to identity procurable if an order of committal was desired.
3. Subsequently personal evidence of identity became unnecessary as the Magistrate was satisfied after the photograph had been produced in Court.

With reference to your letter dated 24-6-14, I have the honour to inform you that the Magistrate declines to commit Hans. In the matter of the acceptance of a photograph as evidence of identity and to suggest that the Colonial Office should be informed that it is desirable that a person who is able to give evidence as to the identity of the fugitive should proceed to this country.

No mention is made in the cable concerning any arrangements to take over the prisoner; it appears desirable that this country should be informed when the person authorised to receive the fugitive will arrive at Mombasa.

I agree with the remarks of the Commissioner of Police in reply to (4). It is quite obvious from (7a) and (13) that reasonable doubt was entertained as to the sufficiency of a photograph as evidence of identification and in view of the fact that no expression of opinion could be obtained from the Magistrate as to his views on such means of identification, the Commissioner of Police was justified in urging that if possible the best evidence of identification should be forthcoming i.e. the evidence of some one who knew the absconding offender. It would have been extremely unwise to wait until the evidence of the photograph was rejected before taking steps to procure further and better evidence.
