With reference to your letter of the 26th January (un-numbered) I have the honour to transmit a copy of a letter which we have received from our solicitors on the subject of the Magadi Soda Concession, and to enquire whether the Secretary of State approves of our granting to the Magadi Soda Company Limited a lease and contract in accordance with the Concession dated 20th September 1906, and the supplemental agreement of the 26th January 1911.

2. With reference to the 2nd paragraph of Messrs Sutton Cressney & Randall's letter, we think that a certificate should be obtained from the Company's auditors, but we shall be glad to receive the Secretary of State's instructions on the point.

As regards the last paragraph of the solicitors' letter, I have to state that no specifications, plans or sections have yet been submitted to us.

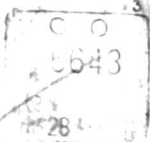

We have to inform you that the Concessionaires have now exercised the option referred to in Clause 1 (b) of the Concession of the 20th of September 1909 and that the notice exercising the option requests that the proposed Lease and Contract shall be granted direct to the Nagadi Soda Co., Ltd. This is pursuant to Clause 3 of the Concession.

By way of compliance with the requirements of Clause 24 of the form of (Contract) and Clause 52 of the form of (Lease) scheduled to the Concession, it was our intention to require a Certificate from the Company's auditors that capital to the required amount had been subscribed and 7/8d in the £ paid up. Messrs Samuel & Co's notice of exercise of the option, however, contains a statement that £1,250,000 of the Company's capital had been subscribed in cash and 7/8d in the £ paid on allotment, and we shall be obliged if you will instruct us whether we are to accept this statement as sufficient evidence in this respect.
