E. A. P. and Uganda.

I have the honour to acknowledge the receipt of your letter No. 33545/1911, of the 21st October, on the subject of the engagement of European Constables for the East African Protectorate and Assistant Inspectors of Police for Uganda.

2. With regard to the Assistant Inspectors of Police for Uganda, we now recommend Mr. James Mathews whose address is the R. I. C. Barracks, Carlow Graigne, Co. Carlow, for one of the vacancies. Mr. Mathews is 25 years of age and unmarried, and has served in the Royal Irish Constabulary since 17th April 1906. He is reported by the Officers under whom he has served to be a good, suitable man and he has been interviewed by Captain Edwards who also considers him to be suitable. Mr. Mathews has been passed by the Royal Irish Constabulary Surgeon as physically fit for service in Uganda.

3. We hope to be in a position to recommend a candidate for the other vacancy shortly.

4. With regard to the four vacancies for European Constables, we have now provisionally selected candidates for

for three of these, and it is hoped that we may be able to engage and send them out to the Protectorate at an early date. We have also several other candidates in view and we do not therefore propose to advertise the vacancies until we have ascertained these are suitable.

Benefits are provided free of rent (but not water
or timber out going) or an allowance is given in
lieu, and an allowance of £10 p.a. is granted
for uniforms. Free 2nd class passages are provided
to & from Africa. Free passage from Mauritius to Uganda.

2 A memorandum showing the general conditions attached to
appointments in the Protectorate and a copy of the leave and passage
regulations for civil officers are enclosed herewith, but you are to understand
that you will be subject to any regulations which may hereafter be introduced
by, or with the sanction of the Secretary of State. A copy of the regulations
as to pensions and a copy of the Colonial Regulations are also enclosed.
