We asked the Gov. as to this allocation of land on 20 Jan. in CA/707.

This resp. was answered by the Gov. on Sept 11/2009. but the specific point was not answered.

From the General tone of the Governor's reply seems to negative the U.C. Co's request for the allocation of land at Kikindia.

As to the plans of plots of land - the Gov. sent home despatch (copy in last month's book) ~~which~~ contained a plan ~~now~~ with the necessary in connection with

of this despatch from which it is clear
that no question of giving a plot
of land to the U.C. is considered.

In any case, it is well
known that the plan should be
shown to the C^o, & as far as I
can ascertain, we have no inf^o
as to the terms on which such a
plot or plots of land would be
leased or sold.

To clear the matter up definitely
I send copy of this letter to
the Gen. for obs^{ns}, referring to
our despatch in CA/787 and Gov's
reply on 10/12/29: ~~say that~~

SIR,

On 2nd December last we had the honour of address-
ing a letter to Colonel the Right Hon. J.E.B. Seely,
with respect to the service we then contemplated
establishing on the East Coast of Africa. The
concluding paragraph of that letter was couched in the
following terms:-

"In view of the large holding of land at the Port
of Kilindini by the Government, we would ask
whether it is possible for the Government to
allocate to us such land as may be necessary in
connection with the shipping work of our new
service."

To this enquiry Colonel Seely replied, in a
letter addressed to Mr Mirrielees on 20th December,
to the effect that the Governor of the East Africa
Protectorate would be consulted as to our wish to
obtain land at Kilindini. We believe that plans
have lately been forwarded to your Department setting
out plots of land, which we assume it is in

intention of the Government to lease or sell to the shipping community, and we should be pleased if we might be permitted to see these plans and to learn on what terms the Government is prepared to sell or lease a plot or plots that might be suitable for ~~the~~ purpose.
