The Commissioner for Lands and the Crown Advocate agree with me in thinking that it will only be necessary to purchase land in the cases where the Government has actually committed itself to grant leases. I have therefore asked for Rs.5,000 for this purpose. In the other cases it will be left to the planters to make their own arrangements with the owners of the land if the latter wish to sell. In two or three instances the leasees have agreed to accept leases of other lands which the Government has the undoubted right to alienate. These include the East African Corporation and Messrs. H. and F. Guest. This is fortunate as in neither case would the Government have been able to purchase the lands under £5,000 of £10,000.

MEMORANDUM WITH REGARD TO LANDS IN THE NYIKA COUNTRY  
NORTH OF MOMPASA.C.C.O.  
5801Recd  
REG: 17 FEB 08

There is no objection to any of the leases of land on the South bank of the Sabaki River. These comprise leases to A.H. James, Goldmann (1st. choice), Abbott, Hancock, and Goldmann (2nd. choice). All native rights, especially at the foot of and on Mount Mwanee, should be reserved.

No further grants of land should be made south of Mount Mwanee.

The land over which the Waiyika have undoubted rights is shown on the map. Several of the Wa-Nyika tribes claim the right to all the land to the Coast, but they are not likely to press their claim, especially if they are informed that sufficient land for their present and future requirements will be reserved for them.

No land should be leased on the north bank of the Sabaki between  $39^{\circ} 45'$  and the Sultan's dominions until a survey of this country has been made. The Giriama who inhabit this area in large numbers have no rights to the land as they have only squatted there during the last twenty years.

The forest capped peaks known as Kaya Chonyi, Kaya Jibani, Kaya Kumba, etc. should be scrupulously reserved.

Sir Arthur Hardinge's speech to the Wa-Rabai and Wa-Duruma with regard to the boundary dispute between those two tribes.

As the Wachokara, one branch of the Wachokara people, are alone concerned in this matter, I have not thought it necessary to call the Elders of the other branches, the Wachonyi and the Waduruma Kuu, and, after listening to the representatives of both your tribes I have arrived at the following decision:-

I can only take into consideration the boundaries as I found them when the British Government placed the land under its protection in July 1896. It is, in consequence, useless for the Warabai to urge that the limits of their territory reached in former times from the Shiaba Hills in the South to Jimba in the North, for, were I to acknowledge these, I should likewise have to allow the Galla to take the whole of the Giriama country and the Masai all the land from Kikuyu to the Coast.

The river Msapuni must therefore continue to be the boundary between Duruma and Rabai.

At the same time after sifting the matter to the bottom, I find the Warabai are a diligent and hardworking people who have cultivated all the waste land in their territory, while in the Duruma country there is still plenty of cultivable soil which has not yet been tilled, and, as it is my wish to aid all these who work for the good of the Protectorate, I propose that, with the permission of the latter people, all the land lying between the Msapuni and the Railway - from the Baebab tree where terminates the boundary, made by Mr. McClellan in October

1896 between the Wajomvu and the Wachagauwe to a line of pillars at Mwachi to be erected under Mr. Hollis' supervision - should be considered as neutral ground and that both tribes should be alike permitted to settle there.

As to the shambas belonging to the Warabai in the Duruma side of the Railway and those belonging to the Waduruma on the Rabai side of the Msafuni river, I am of opinion that they should remain with their present owners but, for all those plots of land which have been appropriated by the Warabai since the Waduruma first raised this question and brought the matter before my notice six months ago, a fine the amount of which is to be decided by Mr. Hollis must be paid to the Waduruma Elders.

Likewise all those Warabai who have continued to increase the size of their plantations since Mr. Hollis commenced this enquiry on January 5th 1898 are to be fined for disobeying an order given them by a responsible Government official.

In future I forbid all Warabai from increasing the size of their shambas or tilling a fresh plot of land in Duruma and, vice-versa, all Waduruma from increasing the size of their shambas or tilling a fresh plot of land in Rabai without first obtaining permission from Mr. Hollis.

In conclusion, I strictly prohibit either tribe from fighting with the other. Should I again hear of any such rumours, I shall send a number of askaries to the various towns to punish the delinquents.

Sir,

I have the honour to report that in accordance with your instructions I have settled the boundary line, previously in dispute, between the Wajowvu and Wachangamwe.

Both parties having agreed to accept the line as defined by the Wazee of the Wa-Rabai and Waduruma a shauri was made by six men of each of these tribes, after which they drew out as nearly as possible what they considered to be the original line as decided upon in a previous dispute about 70 years ago.

I decided that the line thus made is to be final, though all growing crops are to be allowed to the present cultivators, and that all individual rights where coconut trees are five years old and upwards will not be disturbed.

I would suggest that a workman with some red paint be sent to permanently mark the trees along the line.


