My Lord

As an indication of the rapid development which is taking place in Native Administration in East Africa, I would beg to invite Your Lordship's attention to the Hut tax collections of the Kenya Province, the results of which for the financial year ending the 31st March last, have just reached me.

2. The amount realized by this tax in 1902-03 was £.719; in 1906-07 the estimate of £.12,000 was exceeded by £.6,616. In the financial year just closed the actual collections were Rs.414,863 = £.27,657, allocated as follows: Fort Hall = Rs.241,547, Nyeri = Rs.91,236, Embo = Rs.82,080. This means that in a Province where 7 or 8 years ago a rupee was hardly known the natives have, without any pressure, given us a revenue of well over four lacs of rupees. I would particularly invite Your Lordship's attention to the collections made in the Embo country, amounting to Rs.82,080, which was only taken under administration six months before the commencement of the financial year, after a military expedition prior to which the Embo were a menace to the friendly tribes and even unapproachable by friend and foe.

3. I trust, Your Lordship will agree with me that these results reflect great credit on Mr. Lane and his executive staff, and afford a most satisfactory indication of peaceful progress.

I would also venture to urge that this large increase in revenue, unprecedented in my experience, is a powerful argument in favour of the policy I have consistently urged for an increase of the administrative staff ever since I have been connected with Uganda and East Africa. Each Assistant District Commissioner added to the staff pays his salary over and over again.
