



The 2^d Mr. Dickinson's
case - no compensation
is proposed in your
draft for the loss which,
as explained in paragraph
three of the present draft,
would amount to \$100
(i.e. the difference between

months, and might even
amount to \$150 if, -
as might possibly be the case,
when Mr. Hubbard was
acting for the Chief Accountant
his own duty for at the
