Sir:

With reference to the final paragraph of my letter of the 9th June, 1910, I was directed by the Secretary of State for India to enclose 6 copies of each of the forms issued to show on clearance from Aqun, including the adapted Zanibar form of authority to carry the British ensign.

Authority to carry the British ensign.
 Port Clearance for country craft.
 Port Manifest.
 Bond.

It is not clear to Viscount Morley why of these forms more than one need be communicated to the Italian and French Governments, viz. the adapted Zanibar form headed "Authority to Carry the British Ensign". He has accordingly addressed to the Government of India the telegram of which a copy is enclosed, making enquiry upon the point.
