Income Tax Debated in Legislative Council.

STRONG PROTEST AGAINST IMPOSITION.

Not Justified.

UNTIL EXPENDITURE HAS BEEN REDUCED TO MINIMUM.

The people of Kenya were prepared to make whatever sacrifices they were in a position to make for the benefit of Kenya as a whole, and they were satisfied that those sacrifices were absolutely necessary for the good of the country, and were not being called on merely for the sake of hoarding up extravagant expenditures.

The above statement was made by Lord Francis Scott in the Legislative Council yesterday in speaking in the following motion, which was negatively voted upon after debate, by the official majority.

"That this Council is of opinion that the introduction of a Bill to impose Income tax in Kenya should be postponed until the report of the Expenditure Advisory Committee is before the Council, and until the Government has shown that expenditures have been reduced to the lowest figure possible, and that no other satisfactory means are available by which the budget for 1933 can be balanced."

Lord Francis Scott stated that the country was going through an anxious time and was in no position to stand firm taxation.

During the course of his speech he gave details of various official salaries paid in 1931 and those paid during 1932, which comparisons, he said, disclosed a remarkable position, showing that the standard had gone up by 100 to 150 per cent.

Salaries in 1914 and To-day.

By a vote of 14 to 11, the following resolution was adopted: "Resolved, that the Committee on Salaries be appointed by the Legislative Council."

Compulsive Figures.

The gross figures of expenditure in 1932, after deducting the amount of the public debt repaid and the amount of the Government Reserve for 1932 was 1,314,000,000, which was an increase of 100 per cent over the amount of 657,000,000 in 1921.

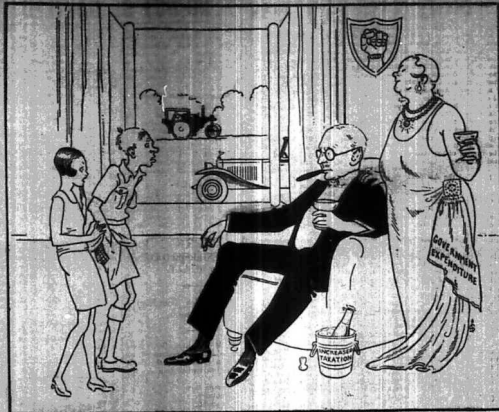
