In Sir E. Grey's opinion the questions involved should in the first instance, at all events, form the subject of discussion between Mr. Clarke and the Government of the British East Africa Protectorate.

Should the Earl of Crewe concur in this view, the necessary instructions will be sent to Mr. Clarke, and I am to suggest that the Governor of the Protectorate should be authorised to enter upon negotiations with him.
