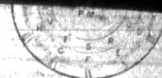

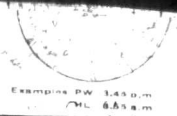

from Officer Commanding the troops Serenli 28th March
begins: Returned Serenli 26th March Rertulha have
brought twenty rifles and have promised to bring more.
Tulha have agreed to fine 500 camels 600 cattle
1000 sheep and goats and have paid sixty cattle as
guarantee. Have given one month to collect remainder.
Think their submission genuine as it appears that they
were deserted by Ahmed Wet when force moved from
Serenli. One small section of Rerhassan also submitted.
Submission considerably eases strain and hope that no
necessity to bring 4th Battalion King's African Rifles
Companies from Yonti. On the way (to) Lugh sent
letter Ahmed Wet hearing rumour that they wished to
submit but no reply received, relieving present garrison
at Garre Bahare and will utilise to maintain pressure
on Tulha and do short patrols under Soames.
Have paid Aulihan friendlies from captured stock and
