MY life brings me into close contact with crime. I therefore believe that the present day is the time to demand the abolition of the death penalty.

The following are my reasons for demanding the abolition of the death penalty:

1. It is a waste of capital.

I have noticed that every year

or two new condemned men are executed.

Therefore, if we spend £100,000

on the death penalty, it will never be recovered.

2. On religious grounds, the death penalty is wrong.

The Fifth Commandment says: "Thou shall not kill." There is no clause to say that it is permissible for the purpose of justice.

Again, the New Testament says: "If one kills another, he must give life for a life; and if a man steals, he must pay for a life."

3. The death penalty is not a deterrent.

It is not a good deterrent, because it is not effective, because that is not possible, because the death penalty is not a deterrent.

4. The death penalty is not humane.

It is not a humane punishment, because the condemned man is usually given a painful, hard and tortuous death.

5. Finally, once the death penalty has been carried out, no one person is found in time.

EICHMANN TELLS OF
JEWISH SOLUTION'

THE Chief Prosecutor in the case against Adolf Eichmann, Dr. Gideon Hausner, told the court yesterday morning, after the defense had called him, that he was not prepared to accept the defense's argument that he was not responsible for the extermination of the Jews.

"What else? We have to accept the evidence of the witness," said Dr. Hausner.

"Gideon, I am of the opinion that the evidence of the witness stands," said Dr. Hausner.

Mr. Gideon Hausner, Israel's Attorney-General, aged 45 who was born in Berlin, is the chief prosecutor in the war crimes trial of Adolf Eichmann, who is trying to prove that he was not responsible for the extermination of the Jews.

He is the fourth witness to give evidence in the trial.

Albion arrived, through

As Attorney-General, he tries to prove that the extermination of the Jews was a crime of international proportions.

Eichmann, 61, a tall, thin man with a pale face, a receding hairline and a prominent nose, is accused of being one of the chief instigators of the holocaust.

Within the grey concrete walls of "Eichmann's Fortress," he is a man who is not easily recognizable, and his jailers are busy day and night trying to identify him.

Secret security measures have been taken to "keep Eichmann in the dark" and to prevent the outside world from learning of his whereabouts.

KADU AIDED BY REDS TO STIR UP TROUBLE, KADU SAYS

From Standard Staff Reporter London

KANU was financed by Comintern, rich Asians and millions anxious to corrupt Kenya politics, the deputy minister of Kadu, Mr. M. M. Muthuri said in London yesterday.

No European had given any money to Kadu, who had raised funds for his campaign by selling cattle and land.

Mr. Muthuri and Mr. Peter Kariuki, a week after their return from Geneva, told that whatever he did not oppose him—if he stood for Kadu's election as a detraction of Kenyatta and his "fascist" policies, they should "forget it," and that he would fully join the elections.

Few differences

Answers to questions if Kadu decided to stand in the next election, Kadu said that he had no objection to the principle of independence.

He said against the party's code, Mr. Muthuri said, "I would not stand for Kadu."

After questioning Dr. Muthuri agreed there was little difference between the two men on land, education or agriculture.

Kenya did, of course, stand for independence, the president of the Kenya Chamber of Commerce, Mr. D. R. Gurnam, said yesterday.

Kadu had no quarrel with Kenyatta, he said, but the rapid rise of Kenyatta as a Chief Minister as against a mere African Chief Minister was a new approach.

New approach

Kadu came from Kampala, however, on the principle of a particular party's policies, he said. It was not his party opposition to Kenyatta, Gurnam claimed.

The main difference between the two men, he said, in principle, was that Mr. Muthuri was more pro-American than Mr. Muthuri, and the two men had similar roundabout ways of arriving at their conclusions.

"Such questions must await the final results," he said. "I have the right to stand in an informed manner at the election."



AIRCRAFT ON THE BEAM—WITH I.L.S.

The Instrument Landing System which is to be installed at Nairobi Airport early next year can bring aircraft down to 200 feet in the dark. The system, developed by Fokker, has been adopted throughout Europe and is in regular use at R.A.F. stations abroad. It works by remote control from the airfield control tower.



Landing through a gap in the mountains


HAROLD AIRPORT is circled by a range of hills. Pilots have with a single approach transmitter a choice of three landing routes over a centre gap. The aircraft must be on the course and on the center line of the gap to land successfully after testing all landmarks.

The picture above shows a pilot about to land on the runway. The accuracy of his descent guided by the instrument landing system. The picture on the left shows the aircraft approaching and transmitting.



...AND THIS IS HOW IT WORKS

In the diagram below the two important features of I.L.S. are shown — the localiser approach transmitters beyond the end of the runway, transmitting the former, radio waves of two different tones. When the aircraft is exactly on line for the runway the two tones will be balanced; but when it goes off course the tone changes and the error is shown on a meter on the pilot's instrument panel. The glide path transmitter works in a similar way to indicate the aircraft's descent. The monitors shown near the two transmitters help to detect and correct any variations in the beams. The diagram also shows three marker beacons — although some airports use two — which give positive range indication.




