**UGANDA COUNCIL HEARS  
ABOUT THE COST****Select Committee to go into  
salary questions**

**A**FTER a lengthy discussion, the Uganda Legislative Council sitting at Kampala, this week agreed to the adoption of the Civil Service Selection Committee Report subject to the appointment of a Select Committee to consider and report on certain anomalies and salary scales.

Members of the Select Committee will consist of three members appointed by the Government, one member appointed by the civil service, one member appointed by the Uganda Bar Association, and three conditions for the formation of the committee will be that it must be kept as small as possible, and that its work must be kept confidential.

The Select Committee will be required to submit its report by the end of January next year.

Moving the report, the Chief Secretary said that the Committee had found many signs of severe regional inequality in the salaries of civil servants throughout the country as a whole, and also in the civil service in the different districts of the country.

Discussions had been held with the financial services, and the Government had decided that the Select Committee should go to meet their objectives.

The Select Committee had presented a compromise which it had been asked to do, and resolved.

**Salary scales**

Their committee, though of varied experience, and some of them, if necessary, would have to be brought up to date, would like to be given the benefit of all the information available.

Moving adoption of the Bill, which gives power to Uganda's Government to censor and disseminate statements in the Press, in an article in the "Daily Monitor," the Chief Secretary, as already reported, said that the Bill was to be used under the power provided for in the Constitution, and that efficiency and later on a promotion bar, if necessary, would certainly be given to the editor of the newspaper concerned. The Acting Financial Secretary said that the editorial section of the newspaper concerned should not also operate.

Mr. Gaye said that the editor of the newspaper concerned should not be allowed to interfere with the liberties of the Press.

The Bill, he said, was not intended to control the Press but was designed to control the Press and disseminate false and distorted statements which might be the means of harm.


