

THE HODGE COLLECTION : INTRODUCTORY NOTES

Mr. Stephen Oswald Vere Hodge was born in 1891. He came to Kenya from Britain in 1914 as a Settler. He got married in 1919. He was employed as a District Commissioner for Southern Karachuonyo Districts in Kisii between 1927 and 1929. During this period, Mr. Hodge acquired a residential plot of approximately 30 acres from Mr. Stringer in Subukia area in Rift Valley Province. In 1933, Mr. Hodge acquired a further 1998 acres of farmland from Mr. H.C. Stiebel of Natal South Africa. This farm was adjacent to his residential plot and he bought it ^{at} a cost of 42,000 shillings. This is what later came to be known as Sidai Farm and from which the collection was created.

Mr. Hodge resigned from the Government service as an Administrator in the late 1930's to manage his farm. In 1959 Mr. Hodge, through his lawyers succeeded in forming the Sidai Farm Limited, a Company with limited liabilities and with its headquarters in Nakuru under the management of Mr. Hodge, Mrs. Hodge, their three sons Donald, William and Michael Hodge in the board of Directors. Between 1971-1973 there were attempts by Mumanda Farmers CO. LTD to purchase the farm but this proved unsuccessful.

The Hodge collection contains records of his life history in Kenya dating from 1914 when he arrived in the then British protectorate. The records consist of photographs of various people as well as landscapes. These were taken during Mr. Hodge's travels and expeditions on arrival in Kenya. They are captioned and arranged in an Album-Diaries which number 19 record mainly official meetings and luncheons. Family dealings which are recorded to a large extent also relate to the running of the farm. The diaries also contain birthday records for the members of the family and friends. Rainfall figures, accounts and farm produce which bear some unique importance are also recorded in these diaries.

The bulk of the collection constitute papers created through the administrative processes within the farm. These include NSSF and GPT reports, Labour records pertaining to duty attendance, work done in the farm; K.F.A. Vouchers; Income Tax assessment report, Livestock returns; Bank Statements and Auditors reports; Muster rolls for employees' payments and sundries. There are also records showing Mr. Hodge acting as a Magistrate in his capacity as a District Commissioner. Included in the collection are Trade Union dues, Workers compensation and correspondence from various organisations such as Government officials.

The collection is arranged in series according to subjects. These records are put in archive boxes which number from 1 - 45.
