Your No. S. 216 of oth February. The Rhodesian Contingent is about 400 strong and is organised as an Infantry battalion of 4 companies with paymaster and medical officer and machine gun section, but without transport as at present arranged. We are sending out for the Contingent 500 long 303 rifles sighted for Mark 6, with bayonets. 2 Maxims with tripols for Mark 6, and 550,000 rounds small-arm ammunition Mark 6. 476 sets Infantry Web equipment, 500 helmets, 500 greatcoats, 1,000 pairs boots and other stores. The whole consignment may be expected to reach Kilindini by Class Line steamer about the end of March. The Contingent, however, will bring with them from Rhodesia, rifles, bayongts and 100 rounds ammunition per man. These are to be returned immediately on the arrival of arms despatched from England.

With reference to the last paragraph of your telegram, we shall be glied to know

the latest reliable information you have in regard to hostile forces.

From War Office to Major-General Wapshare.

Admiralty can make immediate provision of two battalions of Marines, such 1,000 strong, and six 12-pr, guns for the purpose of cutting out the "Königsberg." If necessary, these could be strengthened by naval contingents from the ships. Senior Naval Officer has been asked by the Admiralty if this force would suffice for the operation, and how long it would take when once it had been begun. The actual direction of operations on the spot would be entrusted to you, and you should report on the project. It is most important to capture the "Konigsberg" and her crew and to liberate the valuable cruiser "Weymouth" for service elsewhere. Marines can sail on 17th February, and would arrive at Mombasa about the middle of March. You should confer with the Senior Naval Officer and report here at the earliest possible date.

Your No. 3050, M.O. 176, of 12th February. The enemy's strength in the Tanga - Moshi area is as detailed in my No. S. 200 of 30th January, plus 25 Maxims and is guns. The threat on Tanga having been removed by my evacuation of the Umbs, the enemy has again concentrated on Moshi. The dispusition of hostile forces is as follows .- At Ruanda, 1,200, mostly levies, with 10 Maxims and 6 guns; at Bukoba, 44 whites, 350 regular black troops and 500 levies, with 4 Maxims and 3 gens; at Muanza, 100 whites, 100 regular black troops and 500 levies, with 2 Maxims and 5 guns; in the neighbourhood of Sherati 30 whites, 100 regular black troops and 150 levies, with 1 Maxim and 1 gun. The strength on the central railway from Dar-es-Salaam to Tabora has not vet been ascertained

I hope you have received my No. S. 215 of 6th February, re proposed railway from Voi to Maktau. The rain begins soon after 15th March, when except in the case of Lake Victoria, active operations will be difficult, but it will not prevent the construction of a railway, and this in my opinion, would be the best way to utilize the rainy months

till July.
