No. 50. With reference to my telegram 19th February
No. 44. It is reported that Marehan are holding General
Council to decide whether they should join Aulihan and
Power consider^s it quite likely that they will do so as
men belonging to Abdulrehman Mursaal have been sent to
their country to travel through it if Marehan permit
~~to~~ as far as river Daus. Power also February 21 reports
that Mohamed Zubeir not to be trusted and fears that
attack upon Kismayu will be made unless troops can be
sent immediately. Mure with Arab Rifles left February
26th and should be there by now; war ship also left for
Kismayu same day. February 22nd Provincial Commissioner
Tanaland reports that natives state it is rumoured that
Llewellyn Assistant District Commissioner Wajheir was
being held by Somali between Wajheir and Korororo.
~~to~~ to date no confirmation of this report and no news
from Wajheir so it is to be presumed that nothing of
great importance has taken place in that district.
Further evidence has been received that the Abyssinians
gave assistance to Aulihan and Elliot was able to
obtain possession of letter signed by Abyssinian Chief
promising that help will be given them. Believe
that presence of troops and ~~war~~ warship at Kismayu will
have good effect on tribes south of Jubaland; additional
troops not available.
