Sir,

With reference to Mr. Harcourt's Confidential Despatch of the 7th of January, 1913, I have the honour to report that I have recently had under consideration with the members of my Executive Council the question of the recovery from Major W. H. Macmillan of the costs due from him in respect of the proceedings taken in the Land Registration Court by members of the Tangana tribe in 1914.

2. Having regard to the valuable services which have been, and are still being, rendered to the Protectorate by Major Macmillan, both as a member of my War Council and in the field, and in view of the munificence with which he has supported the various charitable organizations which have been promoted locally from time to time, we have not considered that any action should be taken to recover the amount. With this opinion I entirely agreed and I caused the Auditor to be informed accordingly.

3. That Officer, however, desires to challenge this decision under Colonial Office Regulation 277 and I therefore report it for formal sanction. The sum in question is Rs.2571:42.
