Your telegram 28th December am requested
by British East Africa Indian Association transmits
to you following resolution passed and to ask that
copy should be forwarded to Secretary of State for
India begins resolved this association protests
strongly against local governments reservation
British Indians are ineligible acquire residential
parts in proposed auction sales of ²¹plots Mombasa
September 2nd and that they would not be permitted
to live there except as servants of Europeans.
This discrimination most unfortunate especially at
a time when Empire engaged in righteous war for
world's equal opportunity of liberties. Indians
entitled equal treatment other British subjects
being second to none in their loyalty crown and
heavy war sacrifices whereas it is obviously sought
to deny them privileges accorded even to foreigners.
Such Government actions bound create acute racial
animosities and had bleed among different sections
which calamity our association most anxious see
averted. Anxious as they are Indians of this
country not to embarrass Government at time it is
engaged

in engaged/more serious matters yet they feel they would be failing in duty both to themselves and to Empire if they passively suffer themselves thus ? to be deprived of elementary rights citizenship. Our relations with this country dates back to time when neither this country nor India had the honour to come under British supremacy. This association requests home government instruct local government delete said objectionable conditions in proposed land sale and also generally in future refrain from doing anything of nature of give artificial undue advantages to one race over another. Indians here look forward to full citizenship. Local government as a rule express regret that inability to redress grievances when representations made by our association. Such treatment resented by whole community. Our association is urged to take active constitutional steps, as will compel attention to Indian grievances. Humble prayer to remove said humiliating conditions and save community from plunging into active agitation ends.

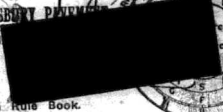

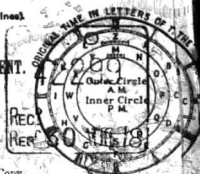
