With reference to my telegram of the 12th March last, I have the honour to forward herewith an application for a military pension from the widow of the late Lieutenant R. W. Gordon Patchett, Military Labour Bureau, who died of pneumonia whilst on sick leave at Naivasha on the 7th March 1918.

Owing to the difficulty that was experienced in obtaining medical advice and treatment for Lieutenant Patchett during his last illness, it has been difficult to decide whether his death was attributable to military service. It appears, however, that the deceased had been serving in German East Africa for 18 months, and had been granted short leave to visit his home in Naivasha. During that period he was examined by an officer of the Royal Army Medical Corps at Nairobi, who found him "in poor general health and suffering from severe chronic dyspepsia" and granted him 14 days sick leave from

from the 18th February. This was 17 days  
 previous to the late of his death. The only  
 medical certificate obtainable is that of the  
 Indian Surgeon Major at the Nainivalla Hospital,  
 a copy of which is attached. If this certificate  
 can be accepted, the deceased would appear to be  
 eligible for a military pension of Rs 30 a year  
 under Section 104 of the Medical Department Act  
 as amended by Army Order 3 of 1916.
