With reference to your letter of 5th instant, ^{Gov} No. 13540/1919, regarding War Gratuity in the case of the European Non Commissioned Officers and Men of the local East African and Nyasaland Forces, I am commanded by the Army Council to inform you that they concur with Mr. Milner's view that the gratuity should be assessed at the rates under the conditions of Army Order 17 of 1919, and that the agreement should have retrospective effect from August 4th 1914, and that in every case the incidence of gratuity follows that date, i.e., that for any period of War Service during which the gratuity is chargeable to Colonial funds, any war gratuity payable in respect of the same period should be similarly chargeable.
