Sir,

I am commanded by the Army Council to acknowledge the receipt of your letter 52916 of 20th September, enclosing a copy of a despatch from the Governor of the East Africa Protectorate from which it is noted that the Chief Quartermaster, East Africa Pay Corps has estimated the cost of the initial equipment of certain local units as follows:—

East Africa Mounted Rifles.	£4,068.	15.	0.
East Africa Rifles	695.	0.	0.
East Africa Pioneers	402.	0.	0.

It is understood that the Common Charges Account has borne the cost of initial equipment of these units, but as this appears to be a proper charge against the Protectorate Government having regard to paragraph 6 of the Memorandum on the Common Charges Account, I am to request that subject to the Director of Military Audit being satisfied as to the reasonableness of the Chief Quartermaster's estimate, you will be so good as to instruct the Protectorate to refund the amount involved to the Common Charges Account. I am also to request that, if this account has borne the cost of initial equipment of any other units chargeable to the Protectorate, a similar adjustment may be effected.

With reference to paragraphs 3 and 4 of the Governor's despatch regarding the salaries of the Committee of Supplies, I am to invite attention to that portion of War Office Letter 0165/187091 (F.L.) of 27th February, 1917, dealing with the Committee of Supplies, and to say that it is considered that if it is not possible to adjust the salaries of the Committee as proposed in paragraph 7 of War Office letter of 15th June, 1918, numbered as above, the Common Charges Account should be relieved of the whole cost of the salaries of the Committee and the Protectorate debited therewith.

I am to request that a report may be furnished in due course stating what action has been taken in the above matters.

I am etc. to ack. the recd. of your letter of the 30th of Sept. No. 10185/7734 (E.A.P.) and to transmit to you, to be laid before the A.C., the accompanying copy of a despatch which is being sent to the C.E.G. of the E.A.P. on the question of charging to the Common Charges Account of military expenditure the salaries of the Canteen of Supplies. Lord Milner observes (10663/17) that the W.O. letter of the 27th of Feb. 1917 to which you refer, does not deal directly with the question of the salaries.

2. With regard to the first part of your letter, Lord Milner agrees that the cost of the initial equipment of the E.A. Mounted Rifles and the E.A. Rifles would properly be charged to the Common Charges Account. With regard, however, to the initial equipment of the E.A. Pioneers he trusts that the A.C. will give the matter further conside. The

I have etc. to acknowledge
the receipt of Major-General Sir E.
Northey's Conf. despatch of the 22nd of
July last, and to transmit to you the
accompanying copy of corres. with the
W.O. on various points connected with the
Common Charges Account of military
expenditure in East Africa.

2. With regard to the 4th para.
of Sir E. Northey's despatch I would invite
your attention to para. 54 of the Report
of the Director of Military Audit on
the accounts up to the 31st of March,
1915, copy of which was enclosed in Mr.
Long's Conf. despatch of the 13th of
April, 1917. In that para. Lt. Col.
Barnes stated that subsequent to Feb.
1915 the Central Committee of Supplies
purchased only on behalf of, and as
required by, the Military, and that he
had been able to trace the purchases
into the Supply and Transport depot store
accounts.

I ^{shall} ~~should~~ be prepared to make further
recommendations to the Army Council
on the subject with a view to the
salaries of the Central Committee
being charged to the Common Charges
Account from Feb. 1915, when I have
received from you confirmation of Col.
Barnes' statement, and a definite date
in Feb. 1916 after which the continuance ^{work}
of the Committee as regards civil supplies
terminated. *and the end.*
