Sir,

I have the honour to ask whether it would be possible to grant permission for the Laboratory Report to be published annually instead of, as at present, half-annually.

Under the present conditions of shortage of staff and excess of routine work any report must consist practically entirely of a chronicle of routine examinations. Even such a chronicle requires considerable time in preparation. From the very nature of the report most of it has to be written in the Laboratory and neither the Acting Analyst nor myself can at present find any time free from interruption for collection of material or recording of results.

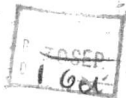
