It appeared from 37/46 that the filling in would cost £3000 & the building construction £4000 more & that this was no provision for the latter.

It now appears that they will be able to construct their sidings for £3000 instead of £4000 & that provision has been made for this under the £3,000,000 Loan.

As regards this last point, the Schedule to the Loan Ordinance merely provides, under (b) 7,

which is no doubt the item referred to.

But, if we were not justified in interpreting Mr. Eastwood's relaxation of foreshore as including the construction of sidings, it seems ~~undoubtedly~~ equally unreasonable to require filling in foreshore as provision for the same purpose. So far from the money having been provided for the construction of sidings, the foreshore to allow this £3000 for the sidings seems to be yet another re-allocation.

Very possibly, the explanation is that Mr. Taylor's £3000 for filling in, in 36/18/14, & Mr. Eastwood's £3000 for relaxation, in 7009 ¹⁴/₁₅, represent the same sum, & that the former has been overlooked hitherto & is now regarded as available for the construction of sidings. I think we need not object.

Ask: & approve of the £3000 provided foreshore, ~~with the £3000~~ the £3,000,000 loan on "filling in foreshore" being applied to the construction of sidings, and but point out that as a further advance of loan funds cannot be expected for some time temporary provision will have to be made for meeting the cost from some other source if it is denied to complete the siding scheme without delay. ~~W.S.~~ W.S. 30/12/15

Sir,

I have the honour to acknowledge the receipt of your despatch No. 527 of the 25th of August, on the subject of the allocation of expenditure under the Imperial Loan of £375,000.

2. With regard to the item for "Warehouses and Reclamation of Foreshore", the cost of the construction of sidings was not included in the sum of £3,000/- mentioned by the General Manager in his letter of December 14th, 1914 which was enclosed in my despatch No. 1049 of the 2nd idem.† It was recognized that the work would take some time to carry out, and the provision was asked for the reclamation alone.

3. The permanent way necessary for the sidings, if second hand material be used, would not necessitate the expenditure of £3,000, and the provision for this part of the work has been included under "Reclamation of Foreshore, Kilindini, £3,000" in the new
