Your Private Secretary wrote to me on 6th
November 1931 informing me of the receipt by you of my letter
of 19th September and that the points raised by me in that
letter and those discussed at the interview with Dr Drummond
Shiels in May, had been referred to the Governor of Kenya for
his comments and that you would write to me again when the
Governor's reply is received.

i am sorry to say that I have heard nothing further up to now.

I am not aware of the Kenya Government's arguments against the subjects we raised and it is only fair, I submit, that we should be given the opportunity of further explaining our position in the light of those arguments if any.

Having discussed these questions with Dr Drummond Shiels, the then Under Secretary of State for the Colonies, and being promised a reply, I informed my Community accordingly on my return here.

for information regarding the decision you have arrived at on the subjects and I shall be obliged if you will please let me know, for the information of my Community, your decision on the following subjects which formed part of our interview with your predecessor in office, in your presence and mentioned in our Memorandum to the Joint Parliamentary Committee and in my letter of 19th September 1931 to you:-

1. Abolition of the Post of Liwali for the Coast.

- 2. Conditions of Service in regard to the Liwalis, ketus
- 3. Condition of Service in regard to the Arab Clerks.

when the Estimates are sent for your approval. I need not say much in favour of retention of the post, you yourself know what will improve the condition of the Arabs both in the Service and the Community as a whole.

The question of Education has again come to the front by the impending opening of the newly built socalled Secondary School at Shimo-la-Tewa. The Gov-rnment proposes to limit the teaching there to Junior Cambridge and would not agree to the abolition of the system of teaching Swahili in the School. We simply cannot understand what is in the mind of the Government and why the attitude of refusing to teach Arabic as the second language and increase the English Education to at least London Matriculation as they do in all Indian Schools. They insist upon limiting the carricullum to only Junior Cambridge and that Kiswahili and Kiswahili only will be taught. Mbarak Ali Hinawy who always argues with the Education Department's Official on questions of Education and whoes arguments against Kiswahili and for Arabic and increase of English Education, the Education Department cannot refute, has now had to k-ep quist after having been threatened by his Officers. From the Director of Education down to the Principal of the School, they are all against the advancement of Arab Education. I believe it is more dangerous to have an unsympathetic Principal than a hostile Director of Education but we have both and here again our only hope lies with your interaference.

We unsertand that a draft Bill instituting an Ordinance to remove the Arabs from the definition of the tern Native in all the Laws of the Country has been sent to you for your approval and we are glad that in this matter a start has at least been made.

By your membership on the Joint Committee and now as the Minister directly responsible for our well being we are sure we greatly stand to gain and we await the findings of the Committee with a certainty that we shall not be forgotten as it had been the case in all previous Commissions visiting East Africa.

There are no signs of the Covernment taking steps to it inde the Arab Clerks in the same terms of Service as the Indians as comes and the terms of Service of the trab officials still remain lower than those of Indian or Goan Clerks. Great delay was experienced in setting up the Service. The report on its working is expected in the spanner of this year - see No. 2 on 16241/30.

The Arab clerks, or some at least 6: them, are probably of a bigher class than any of the Africans, and it would seem quite possible that they have a distinct grievance here.

I would suggest that the Governor be asked to pay special attention to the position of Arabs under the new service in the report which he is due to furnish this year on the Working of the service, and to say particularly whether the conditions offered to the more highly qualified and senior clerks are sufficient to attract the best men, whether Arab or African.

Passfield's despatch No.347 of the 21st May, 1951, enclosing a note of an interview which the Parliamentary Under Secretary of State for the Colonies gave to Mr. Wharak Ali Hinawy and Sheikh Hamed Mohamed bin Issa, the Arab witnesses from the Colony to the Joint Select Committee on East Africa.

- with regard to paragraph 4 of the note, it is true that there has been some reduction of Staff amongst the Arab Administrative Staff during the last 15 years or so. The reduction has been due in the main to the following causes:-
 - (a) A general tendency on the part of Arabs and Natives to move from outlying areas towards Kombasa, due to the growth of individualism and a greater demand for money and appreciation of the advantages offered by the possession of money. It is the same movement as that which can be noticed in the Reserves in fact, there has been a worldwide tendency for people to congregate in towns which offer greater possibilities for earning money and securing a more comfortable standard of living. This has meant work has decreased locally, more particularly in such places as koka, Mambrui and the District of Lamu.
 - (b) Improved means of transport and the opening up of districts by roads, which has made it possible for greater distances to be covered by any one official and has therefore facilitated reduction of staff.
