I have the honour to refer to Letter Serial No. 2 Despatch No. 305 of 1932 in which I asked for the subject of the classification of areas in use in the Colony and Protectorate.

2. For your information, I forward two copies of a pamphlet showing the classification of areas as at the 31st December, 1932, and two copies of a pamphlet showing the Analysis of areas of Administrative Districts as at 31st December, 1932.


3. A memorandum is also enclosed excepting the difference between this compilation and the one for 1931, and reasons for these differences.

4. You will observe that the areas under Native Occupation have increased by 63 square miles. The greater part of this increase is due to the correct fixing on the survey maps of Silliman and Karpaddo Post by which the area of the latter is increased by 49 square miles and the area of Turkana reduced by a similar amount. Turkana, not being a Native Reserve, is included under the heading Unsurveyed Crown Land but, as it is occupied already by natives, the increase in question is statistical rather than real.




