My Lord,

I have read with great interest the accounts which from Lordship has been good abough to send me in your despatches. Acc., 1896 (A 7418/444/60) of the 17th December and 88 (d 160/160/19) of the 3rd instant, according your sourcemations with the Italian ambageature regarding Jubaland and the Decembers.

in the ecerce of a recent private conversation at this imbanay with the Secretary General of the Italian Ministry for Persign Affairs I asked Senator Contaring thy on earth the Italian Government and thought fit to put ferward new and obviously incomptable demands for the consecution of further territories in Jubeland. It was hepelose to expect the British Colonial Office to agree to descions vitally. affecting the British personations in that part of the world. The setion of the Italian Severament must inevitably bring about the failure of the megotiations with Your Lordship which it would have been so timely to conclude. I should say that Senator Conterint was not himself in agreement with the attitude adopted by the Italian devergment in the matter. But he explained it by declaring that it was absolutely necessary from the point of view of internal politics for Signer Ansoclini to show that he had obtained in these negotiations something more than had been considered insufficient by preceding Italian Governments. Contagini them maked me whether I could not explain to him privately why His Majosty's Government were so interested

in the Dodecanese and determined to out down the Italians to as few islands as possible. As it owing to admiralty objections or were His Majesty's Government bound by some secret promise given at one time or another to Monsieur Venizelos in the matter? I replied that so far as I knew His Majesty's Government were simply actuated by principles of seeing justice done. The islands were Greek with a Greek population. At this point our conversation was interrupted by another guest.

During the interview which I had with signor Mussolini yesterday evening His Excellency was obviously disinclined to make any reference to the conversations between Your ordship and the Marquis della Forretta. But I inferred that they had caused him some ill-humour by as allusion, which he let fall, to the favourable prospect of angle—Italian relations in foreign affairs when and if a Labour government came to power in angland.
