2.	<p>Local Clearing Office established by the Local Clearing Establishment Ordinance, 1921, to be Local Clearing Office for the purposes of the Treaty of Peace (Austria) Order, 1920. By an unfortunate oversight which is regretted the "Local Clearing Office Establishment Ordinance, 1921", is referred to as the "Treaty of Peace Ordinance, 1921", which was its original title. It is hoped that this error will not in any way affect the operation of the Ordinance.</p>
	<p>Treaty of Peace (Austria) Order, 1920, to be applied with such modifications as necessary to render the Order applicable to the Colony and Protectorate;</p> <p>(1) Custodian named in Order means Custodian of Enemy Property under the Trading with the Enemy Ordinances, 1915 and 1916;</p> <p>(2) Substitution of the Trading with the Enemy Ordinances, 1915 and 1916, for the Trading with the Enemy Act, 1914, in sub-article I (x) (c) of the Order;</p> <p>(3) The Interpretation and General Clauses Ordinance, 1920, to apply to the interpretation of the Treaty of Peace (Austria) Order, 1920.</p>
