fine for obstructing or hindering or breach of Ordinance.

53. Every person is liable to a fine not exceeding Rs. 750/ who—

(a) Obstructs or hinders any officer acting in the discharge of his duty under this Ordinance.

(b) Commits any breach of this Ordinance or of any regulations thereunder for which no specific penalty is imposed elsewhere than by this Ordinance.

54. All fines and penalties under this Ordinance may be recovered as a civil debt recoverable summarily.

55. The Governor-in-Council may make Regulations not inconsistent with this Ordinance, prescribing all matters which by this Ordinance are required or permitted to be prescribed, and necessary or convenient to be prescribed for giving effect to this Ordinance.

LAND TAX

The following scale of Land Tax is suggested for introduction for the first year under section 1 of the Bill:

On the first Rs. 7,500 of value at tax of	5%
