possible risk of the tribe being exprepriated in the future their representatives have agreed to create a 'wakf' in connection with an area of 3,000 acres near Takaungu . 4.e. a trust will be created in virtue of which this land will be reserved as a communal block for the use of the Mazrui for ever. I attach a copy of the document signed by the leading members of the tribe agreeing to this arrangement, which will ensure a sufficiency of land for the needs of its members, even if the entire balance is sold to private purchasers.

In these circumstances I think that it would be inadvisable to interfere with the disposition of those areas in respect of which the Magrui will in due course receive certificate of title.

With reference to your Confidential despatch of January 7th respecting the Eastui lands, the reply to which has been unavoidably delayed pending negotiation with the interested parties, I have the honour to report as follows.

Owen Thomas of such a proportion of the Mazrui holdings as would leave insufficient provision for the needs of the tribe I am new of opinion that as apprehension need be felt in this direction, as the land alienated would not include any of the present cultivated shambas but would consist entirely of bush and wasteland suitable for planting sisal but useless for any other purpose. Such areas would not develope by the Mazrui themselves and the purchase money can, as they assert, be more profitably employed in working their existing plantation.
