The Staff of Inspectors in the EAST. Police is full of anomalies:-

Hunter & Hilly, app^{ts} by the F.O., are on the same footing as inferior officers as regards leave & pension, although in error in their letters of app^{ts}

In his help on 21.50/06 the C. however asked that all Inspectors might be app^{ts} in future on the same terms as inferior officers.

Messrs Chevers (42504/06), Tanner & Wilmot (5586/06) were app^{ts} accordingly, though only receiving 2nd cl. passages. One Sgt reply on 21.50

however made no reference to this recommendation & although we have acted on it, we have done so without coming to any formal decision on the point & without going to the Treasury as we should have done.

again, Messrs FitzGerald, Lysons & Fother were temporarily off ~~the~~ locally, presumably as subordinates, and Milton & Richardson, who are acting as Inspectors, are serving actually under agreement as Sgt. Instructors. These five men are now recommended for permanent off ~~the~~ as Inspectors. The 2 senior Insps, Bentley & Stokman, are Insps, subalt.

Some are therefore subordinates, some superior officers, as regards leave & pay, while others are temp. employed by or else Sgt. Instructors on agreement acting for the moment as Inspectors.

A proposal is now before the Coy to place all Europeans on the same footing as regards leave & pay (as in W. A.), & the question which is considered by the Coy is whether we are to anticipate Treasury sanction & confirm these men or temporize until the Coy reply.

? Until we hear from the Coy, I would suggest that we had better leave things as they are & if the Govt accordingly, adding that if Sgt. Instructors & Richardson are prepared to re-engage on agreement for a further 3 years, they might be given 6 mos leave at 1/2 rate (as also may Sgt. Instructors who wish to re-engage unconditionally), & that in view of the fact that the rates for Europeans are levied has & will be prepared to ~~at~~ the ~~same~~ rate as for British, & to refer the question of their previous service counting towards pension to the Coy for further consideration, but that no assurance can be given that such service will be permissible.

If Lt. Col. 5 Richardson do not wish to re-engage on these terms, the Govt should give me notice of their being available for re-employment as an early date, for in that event they will of course not be entitled to any leave of absence.

and as to the W.O. if there is any objection to our re-employing Lt. Freeman for 3/4

I am not very anxious to increase the number of men of the N.C.O. class permanently engaged, but Milton & Richardson seem good men of the kind, & I don't think in present circumstances the Govt. can afford to lose them. I should therefore proceed as proposed, but I think we must first regularize the position by asking the Treasury if any being made of Mr. Madden's present position as far as of our making the other provisions favorable on the officers side after 2 years' probation.

Sir,

I have the honour to inform you that the three years' agreement of the following Sergeant Instructors will expire on the 30th June next, and that they are all desirous of re-engaging for a further period on certain conditions which I quote in each man's case, together with my recommendations:-

Sergeant Freeman - States he is desirous of re-engaging for a further period of 3 years at the expiry of his present agreement. The Collector, Baringo, reports very satisfactorily on Sergeant Freeman's work, and considers that it would be to the interests of the Police Force to retain his services. I fully endorse the Collector's views, and strongly recommend his re-engagement on the same salary of £150 per annum. I think Sergeant Freeman should also at the expiration of his present agreement be allowed four months' leave home according to the regulations in force here. He could then be entered into with a fresh agreement on his return on the same terms as the present one, and receive a new outfit at home.

2. Sergeant Instructor Milton - and Sergeant Instructor Richardson - Both these men are now confirmed in the appointments of Inspector, and are willing to re-engage for a further term, provided they are allowed to qualify.

qualify for a pension from the date of their joining the Police i.e. from the 30th June 1904 as they will have to withdraw from the Army and forfeit their pensions from there, I certainly consider their request fair and reasonable and strongly recommend same being adopted. Both of these men are well acquainted with the language of the country and have acquired a knowledge of the Law during their past career, and I would further recommend that they should receive, on re-engaging, the higher rate of pay when an Inspector becomes efficient i.e. £180 per annum.

As both these men are desirous of having leave at the expiration of their present agreements, I recommend, as in the case of Sergeant Freeman that they be granted four months' leave according to the Regulations.
