Sir,

With reference to your letter 1876/1912/1913 of the 23rd January, I am quite unable to understand or follow the charges put forward by the Protectorate Government, some of which are nearly 5½ years old. On my arrival in the Colony on the 15th September 1909, the only existing rooms in the list now submitted were the six marked in red, and the kitchens. My household consisted of six Europeans, including a Private Secretary, who would usually have been accommodated outside Government House. There was no office accommodation. The bedroom accommodation was, I think it will be admitted, totally inadequate, and did not permit of my entertaining any official guests. In consequence, I appealed for funds to build on an office, bedrooms for A.D.C. and Private Secretary, and to convert the attic into bedrooms. These were gradually provided, though I cannot quite remember the dates. They were certainly not completed until the spring of 1910, when their Royal Highnesses the Duke and Duchess of Connaught, with Prince Arthur and the Princess Patricia, visited me in East

the Under Secretary of State,

Colonial Office,

London, S.W.

East Africa - for on that occasion, Lady Girouard occupied the A.D.C's. room and I camped out for ten days in the then newly completed office. The whole of H.R.H. staff and my own being accommodated in tents in the garden.

The accounts as presented are therefore inaccurate. I would desire most respectfully to make a further protest. It is understood that a percentage charge will be made for rooms other than those for public use. I would submit, in view of the above, detailed circumstances that the only private rooms in use were the five personal rooms for I omit the Private Secretary. I cannot see why Government should make any charge for rooms used for entertaining official guests who remain over night, and there were many hundreds of these in the course of my administration. The same principle should, I think, apply to the Kitchens.

The Boudoir mentioned was an upper sitting room available for the public at all times. I never had a groom or groom's cottage, but to supplement the bedroom accommodation a small derelict cottage was re-erected in the garden and was usually occupied by Legislative Councillors from outside districts when attending sessions of the Legislature, as Guests at Government House.

I would bring to notice the fact that although

offered

offered \$400 for the entertainment of their Royal Highnesses, I accepted \$100 as being sufficient, and asked that the remainder should be devoted to the furniture of the house.

Under the circumstances, I trust that Mr. Secretary Harcourt may be enabled to give instructions to limit the charges to a percentage on the occupied bedrooms of myself, family, and personal staff. Here again, I would point out that for more than half the time I was administering the Government my family was in England, and that the rooms thus freed were available for guests.

Throughout the whole term of my office, I did everything in my power to welcome visitors and extend to them hospitality, had I maintained and paid for the bedroom accommodation of 1909, I might have avoided considerable personal expenditure, at the risk, however, of sacrificing, in a measure, the regard of the public.
