He called at this office and stated that he wished to return 2nd class from Marseilles and he would pay the difference to the Union Castle Agents in Marseilles, but he requested that we would provide him with a rail ticket to Marseilles.

Mr. Molloy may be given a rail ticket to Marseilles (2nd class, i.e. as I understand, there is no 3rd class) in substitution for that part of his passage ticket which covers the sea journey to Marseilles. The difference in cost will be paid by the Government.

Sir,

With reference to your letter No. 36872/1913 of the 18th instant on the subject of my transfer, I beg to ask you to be good enough to convey to the Secretary of State my thanks for causing my name to be noted on his lists for consideration with other candidates as suitable vacancies occur.

May I crave your special attention to the following matter when I am sure you will admit the justice of my case and my justification for making the appeal to you.

1. I most respectfully venture to bring to your notice that when I sought and obtained a transfer to the Treasury, Mr. Gosling, the Postmaster General, in his remarks to the head of that Department stated that I was an Eurasian, and to this statement I was constrained to submit to the regulations governing the non-European Staff. After lengthened enquiries I produced to the Governor and the Treasurer of the East Africa Protectorate my baptism certificate which clearly showed that both my parents are Europeans. The certificate I showed to Mr. MacNaughten of your department when applying for a transfer to another Colony.

2. The

2. The above facts prove conclusively that I am a not an Eurasian and it is hardly necessary to point out that the different treatment I am subjected to as an alleged Eurasian is repulsive to me as a British Subject and I now wish my proper status as such to be defined.

I shall deem it a great favour if you will give my case your early consideration as I have to return to Africa early in September.

Again thanking you for your good offices and apologising for the trouble I am giving you.
