No. 71. Following telegram received from troops Serenli March 4th in continuation of my ^{letter} despatch of 22nd February. On February 25th force has captured some 300 stock belonging to Per Tulha taken by surprise; no fighting. Arrived at Garebahare February 23rd, marched to Humbali February 25th, left for Takalla February 26th, our move took by surprise enemy, some 500 sheep and goats. Half force returned to Humbali remainder holding wells Takalla. Wild night attack, number unknown, presumably Ali Sera and Per Hasuan, enemy's casualties three killed. Fine discipline troops good, interviewed Arab Oasis chiefs February 28th, declare allegiance to Government, supplying Illaloes, Graham inclined to believe them. Force arrived at Lolleshid March 2nd. Propose to move Bush, where plenty stock watering Tuba. ^{Health of troops} ^{officer} ~~already~~ commanding Serenli ~~cont.~~
