The Governor of the East Africa Protectorate to the Secretary of State for the Colonies.

(Received, Colonial Office, 4.30 p.m. 17th March, 1914.)

No. 87. Following telegram has been received from troops Serenli: ~~dated~~ March 12th following received from Graham dated March 11th. Returned to Dugh-to-day. Ahmed Wet retired on Dava. ~~granted~~ <sup>granted</sup> permission Her Ali to enter our territory providing they surrender all arms. Abyssinians reported to be establishing post at Dolo; tried to arrange meeting with Dedjas Match Nadu to ascertain, but he did not come. Returning Lossesaid and Serenli: hope to settle Tulha en route. Consider I have not enough troops to effect disarmament and I am ordering two Uganda and one Nandi Company\* to Serenli after arrival rations. There is no danger to our forces but enemy's mobility too great to allow me to do good without holding large circle of inland wells. propose to appoint senior service corps officer Director of Supplies and Transport and I am authorising him to take charge of all such work. Active and extensive movements must be suspended for two months pending arrival of rations and reinforcements. Will go <sup>(?)</sup> ~~am~~ <sup>about</sup> Gouwen to look into details and may come Nairobi as very anxious about food supplies. ends.
