THE EAST AFRICA VOLUNTEER RESERVE AMENDMENT
ORDINANCE 1914.

MEMORANDUM

1. The East Africa Volunteer Reserve Amendment Ordinance 1914 has for its object the extension of the power to form units of the volunteer reserve from members of the Legion of Frontiersmen. Under the East Africa Volunteer Reserve Amendment Ordinance 1911 only one such unit could be formed. It has been considered desirable to allow the formation of units at whatever centres there are sufficient members of the Legion of Frontiersmen willing to join the Volunteer Reserve and form Legion of Frontiersmen Units.
2. The East Africa Volunteer Reserve Amendment Ordinance 1911 is repealed by the Bill.
3. The Bill as passed by the Legislative Council may in my opinion be forthwith assented to and published.
