I, Sworn George Smith, Assistant Inspector of Police stationed in Mombasa, East Africa Protectorate do hereby certify that I was present on the D. O. L. S. S. "Impresso" when one Stanley White was arrested by an Inspector Smetton. I assisted in the arrest and took charge of the prisoner. Prisoner was taken by me before the Town Magistrate of Mombasa who endorsed the telegram (under which the Prisoner was arrested) authorising the Prisoner's detention in custody.

I was also present with the Prisoner when his baggage was searched by an Inspector Smetton and the following mounds of cash and notes were found in a dressing case
