Mr. Deomall was appointed as a telegraphist to the Uganda Telegraph Department on August 1st, 1902, and on the 2nd November will have completed twelve years service and be entitled to a pension of £20-13-10 per annum under Clause II of the Superannuation Act of 1859. His pension statement is attached herewith.

3. Mr. Deomall is at present on leave in India and his retirement takes effect from November 2nd, the date on which his leave expires.

The Board having assembled proceed to examine Mr. Deomal

HISTORY. Mr. Deomal stated he came about 11 years ago to this country. He was in Uganda for six years. He says he thought he had sleep-sickness then and he was invalided in 1907 for Chronic Dyspepsia. On his return he was stationed in East Africa. He was boarded in November 1911 and considered mentally incapable. He was reboarded in January 1912 when he was considered capable of resuming work.

MENTAL STATE. He says he can't do any work - when he attempts to do so he trembles and feels exhausted.

MEDICAL PHYSICAL. Pulse 120 Irregular. Heart (thickened Aortic valves) arteries thickened. Otherwise physically sound for his years (aged 50).

MENTAL CONDITION. His memory is poor - he used to have delusions of persecution, but he now states that he was wrong and that it is God's will that his brain is exhausted and that he should not be fit for more work.

The board considers that he is suffering from Premature Decay, and that he is not fit for further service in the East Africa Protectorate.

If this Paper of Particulars and the Certificates connected with it, be not sent in original, the copies must be duly attested.

Head 1. *Paper.*—In the case of an Officer serving on the West Coast of Africa, a statement is to be added whether he is a native of that Coast. (Colonial Regulations, § 430).

Head 3. State the description of Allowance for which the Applicant is recommended, viz., Subsistence, Compensation, Commissariat Allowance, or Gratuity, and its amount. In the case of Persons claiming additional ~~other~~ Pensions in respect of Professional services, special qualifications should be stated, and a reference should be given to the authority under which the claimed marks should be stated.

Head 5. If the service has been interrupted by one or more breaks, the word "broken" should be added before or after the number of years and months, and the cause, date, and circumstances of the break or breaks should be stated with shading.

Head 6. If the Person retiring has been in receipt of the same Salary, or of the class from which he retires, for the 36 months immediately before the date of his retirement, the actual annual rate of Salary or Wages at that date should be inserted preceded by the word "actual." In other cases the average annual amount of Salary or Wages for the 36 months next preceding the date of retirement should be inserted preceded by the word "average," but if the whole period of service is less than three years, then the average for the whole period of service should be inserted.

Head 7. A separate statement should be inserted of the average annual Value for the 36 months immediately preceding retirement of each Component exclusively of salary or wages which is claimed to be included in the calculation of the pension or gratuity.

Whence the value of a House or House Allowances ascertained exceeds one-sixth of the salary and other emoluments which come for Pension purposes, it is to be reduced to one-sixth of that amount, so that it shall not exceed one-sixth of the whole.

To which an Officer is allowed to retain for his own use will be taken into account for Pension purposes, with regular Salary at the annual average of the net receipts of the 36 months immediately preceding the Officer's retirement. Those net receipts are to be ascertained by deducting from the gross amount of Fees and Office Expenses, &c., as an officer may have had to defray from his own resources in performing the services for which he was engaged in his business. No deduction, however, is to be made in respect of Office Expenses provided from Public Funds, or the due discharge of those duties to which a Fixed Salary is annexed. Papers of Particulars when forwarded to the Colonial Department should be accompanied by formal Declarations from the retiring Officers, showing the amounts received by them for Fees, and the amount defrained as above for Office Expenses, &c., in each of the three years immediately preceding their retirement. It will be the duty of the Colonial Government to satisfy themselves of the accuracy of such statements before forwarding them to the Colonial Offices. In the case of Officers receiving fixed Salaries and Fees, the Fees will not in ordinary circumstances be allowed for grant of Pension purposes to the extent of more than one-twelfth of the Salaries, and Fees will not in many cases be allowed to count for Pension purposes during any period in which the whole sum of the Officer receiving them was not given to the Public Service.

Head 8. In cases of infirmity, if the Applicant is below the ordinary age for retirement, a Medical Certificate is to be furnished showing that he is disqualified by infirmity of mind or body for discharging the duties of his situation, and that such infirmity is likely to be permanent.

In case of ten years' service or more, this Certificate should be signed by two Officers, of whom at least one should, if possible, be a Salaried Officer of the Government.

Head 9. As to "broken" service see Head 5.

If the Applicant has had any "acting" service, the details must be fully given, with a statement whether or not, during the "acting" service, he was connected with the permanent Civil Service of the Colony.

Head 6.—If the Person retiring has been in receipt of the same Salary, or by increments from, which he retires, for the 36 months immediately before the date of his retirement, the net annual rate of Salary or Wages at that date should be inserted preceded by the word "actual." In other cases the average annual amount of Salary or Wages for the 36 months next preceding the date of retirement should be inserted preceded by the word "average," and if the whole period of service is less than three years, then the income for the whole period of service should be inserted.

Head 7.—A statement should be inserted of the average Annual Value for the 36 months immediately preceding retirement of each increment (exclusive of salary or wages) which it claimed to be included in the calculation of the Pension or Gratuity.

It however the value of a House or Office Allowance, &c., claimed, exceeds one-sixth of the salary and other emoluments which could for Pension purposes, it is to be reduced to one-sixth of that amount, so that it shall not exceed one-twelfth of the whole.

For which an Officer is allowed to retain for his own use will be taken into account for Pension purposes, with regular Salary at the annual average of the net receipts of the 36 months next preceding the Officer's retirement. Those increments to be retained by deducting from the gross amount of Fees each Officer Expenses, &c., which may have had to defray from his own resources, in performing the services for which he is emulated, & by fees. No deduction, however, from the Fees should be made in respect of Office Expenses provided from Public Funds, or the due discharge of those offices to which a Fixed Salary is annexed. Papers of "Particulars" when forwarded to the Colonial Department should be accompanied by formal Declarations from the retiring Officers, showing the amount received by them for Fees, and the amount deducted above for Office Expenses, &c., in each of the three years immediately preceding the retirement. It will be the duty of the Colonial Government to satisfy themselves of the accuracy of such statements before forwarding them to the Colonial Office. In the case of Officers receiving Fixed Salaries and Fees, the Fees will not in ordinary circumstances be allowed for going to Pension purposes to the extent of more than one-quarter of the Salaries and Fees will not in any case be allowed to count for Pension purposes during any period in which the whole sum of the Officer receiving them was not given to the Public Service.
